SUBJECT: UIP amendment proposal concerning Article 23.2 GCU

Dear signatory of the GCU

Over the last years, a number of complaints about the RUs' inconsistent handling of cases concerning compensations for damaged wheelsets (Art. 23.2 GCU) have reached the UIP National Associations and the UIP. The UIP internal GCU working group has taken care of the topic and agreed on amendment proposal in order to reach a harmonized handling of the mentioned cases. Please find the proposal in the attachment to this letter.

This proposal then – according to the usual practice – was sent to the corresponding UIC committees dealing with GCU topics beginning of 2012. Until today, UIP has not received a valid statement from UIC – despite of having retrieved it repeatedly. This means that a unanimous decision on the proposal within the GCU Joint Committee is not possible at present. According to Appendix 8 No 7 GCU, "... Any proposal requires either the support of at least 25 signatories or the unanimous consent of the Joint Committee ..." This would be the precondition to start the regular amendment procedure.

After having discussed the situation also within the UIP Executive Board, the UIP internal GCU Working Group recommends to bring the proposal to the GCU signatories according to Appendix 8 No 7 GCU with the support of at least 25 signatories. We therefore kindly ask you to support the attached proposal by signing the also attached declaration and send it back to your national representative in the UIP GCU working group no later than Friday June 20th. As soon as we have collected at least 25 declarations of supporting signatories, we will hand over the proposal to the GCU Trustee and ask him to start the amendment process latest 30th June. This deadline must be respected in order to guarantee an entry into force as of 1st January 2015 – granted that the proposal gets a majority.
